We, at BNP, believe in grasping the essence of the problems of a common woman and in helping her to flourish and flower in her own way. Our focus is women of weaker sections and we aim to prepare them to seize better opportunities for enriching own and family's life. We also trust in educating children through self learning which will reap the benefits of bright career.

We are very glad to present the Annual Report of our activities for the year 2011-12

Annual General Meeting:

AGM for the year 2010-11 was held on 7th July 2011 at Bhoopati Complex, Pune office.

As per the constitution Pratima Joshi and Sulabha Deuskar retired from the managing committee and were elected again on the committee. Pratima Joshi is reelected unanimously as President. Vaijayanti Joshi and Sarita Bhat retired from the managing committee and Pratibha Dhadphale and Amita Kulkarni were elected. Vithabai More is elected as a representative of the Employees for one year.

A report summarizing the annual activities for the year 2010-11 was read out and accepted by all present members at the meeting. The Auditor's Report was also presented and taken on record unanimously.

Mr. Sanjeev Gokhale, Auditor of our Pratishthan, is re-appointed for the year 2011-12.

A meeting of Advisory Committee was conducted on 31st May 2011 to present a report of various activities. This was also followed by some discussions.

Condolences

Vaijayanti Joshi, Ex-vice president of BNP, passed away on 17.2.2012. She always delivered a valuable contribution towards organisation. Our sincere condolences ! May her soul rest in peace.

Some Special programmes

1. Our office has shifted to new premises at Sadashiv Peth.
2. For women at Dighi, a competition "Sundar Maaze Swachha Ghar" was conducted. 60 women participated in this competition. Deeparani Sahastarbuddhe, Hemalata

Vadapurkar, Sayali Palande and Vinaya Dikshit were the judges. Winners of this competition were awarded by Rekha Phadke, Human resources development consultant who was the honour of guest of the prize distribution ceremony held on 4th Feb 2012. Also Dattaji Gaikwad, ex-corporator was present for this award felicitation function.

Each participant was given a flower plant as a gift.

3. On the occasion of centenary year of Bhagini Nivedita, a special felicitation function was arranged on 10th October 2011, to recognise and honour the contribution of 10 such women, continuously active and working in various areas. The certificate of honour and cash prize of Rs. 1000 / - was given to each celebrity by Dr. Sucheta Bhide Chapekar, a renowned Classical Bharatnatyam dancer.

4. On 14th January 2012, various competitions like drawing some pictures using computer, recognition of numbers, recitations, acting, singing a song, storytelling using pictures etc were held specially for deaf and dumb children. About 60 such children participated in this competition.
 5. On 22nd November 2012, we conducted an activity to give practice of science experiments mentioned in curriculum for students externally appearing 10th std exam. of Eklavya Bal Shikshan and Arogya Nyaas Institute.

6. For 10th Std students under the sponsored project of Snehdeep Jankalyaan foundation, activities like practice tests and Answer paper checking alongwith appropriate guidance were executed.
7. Within Dighi area, Yamai Nagar is a locality of 30-40 hutments. This locality, when surveyed at the time of "Sundar maaze swachha ghar" competition, it was observed that basic hygiene and literacy required for a human being are completely missing parameters and nobody there is even aware of that. Ujjwala Gaikwad, a BNP volunteer, went regularly to Yamai Nagar, contacted children and parents. They showed inclination towards studying. So BNP started such Abhyasika and conducted parents meeting. As a response to this, those people made a specific room available for our Abhyasika.
8. All the members of Ushatai Sathe's Marriage bureau visited our office on 5th December 2011. A power point presentation explaining BNP's work was given to them.
9. BNP participated in "Global business conference and business" exhibition sponsored by "International Chitpavan Sangh" during 21st to 25th December 2011. We exhibited all our artifacts there. We received an overwhelming response for the same.

Various activities undertaken by Pratishthan:

Health : A Homoeopathy and Barakshar (Twelve Tissue Remedy) Dispensary at Pune and Dighi is getting tremendous response and number of beneficiaries for this activity is 935 in 2011-12. Apart from regular medications, we also provide guidance and references for the treatment of special type of diseases. Because of such service from our organisation, Mr. Hedau staying at Dighi area, was operated upon without any charges for backbone tumor which he was suffering from, at Deenanath Mangeshkar hospital. Dr.Pradyumna Raiturkar did this surgery free of charge. BNP also organised a camp for Haemogram Checking of Abhyasika Students. Dr. Vijay Karnik and Dr. Kunda Karnik made it available at a concessional rate. Yoga classes were organized for women. Pratima Deshpande shared her expertise and guided women who attended these Yoga classes. About 15 women could get this benefit.

Helper Nurse Training Course:

This course is conducted by the organization, continuously for last 21 years. This course has helped women to become independent. 42nd Helper Nurse Training Course commenced from 4th July 2011.

These trainee girls and members of BNP visited Jankalyan Blood Bank, where Blood group and hemoglobin check-up was done for free for everyone.

On 27th November 2011, certificates of last course were distributed to successful candidates. These girls shared their experiences during the course and expressed their gratitude for Pratishthan. which enabled them learn a kind of living.

Sister Urmila Bhalerao, retired from her services this year. BNP awarded her with a certificate of honor for her contribution in the work area of nursing.

Speech Correction Therapy Center for Deaf and Dumb:

Since Feb. 2011, we have been conducting Speech Correction and Language Skills, development counseling for the Deaf & Dumb children. We started Speech correction center on 2nd May 2011. The teachers namely Madhuri Prabhune, Madhavi Deshpande, Jyotsna Chiplunkar and Madhuri Lohkare look after this center.

Project for Adolescent Girls

The formative years between ages 12 to 18 are extremely important for girls. Apart from physical and mental development, their career also takes direction and shape in these years. Our Pratishthan has started a program specifically targeted towards self reliance and self development of adolescent girls. A group of 15-30 girls has been formed with whom important subjects such as education, personal hygiene, health, sexual awareness, physical and mental changes, interpersonal skills, self defense etc. are introduced. This information is imparted to them via innovative methods such as reading newspaper cuttings, reading books on specific subjects, skits and role plays etc. If need arises, medical aid is also provided. This newly started activity is yet to be established.

In order to scale up the number of beneficiaries for this project, we started these project activities in 7th std at Corporation school and Ramchandra Gaikwad school at Dighi, with the help of the principals of those schools. Even adolescent boys were absorbed in this project.

Computer Training :

Our Pratishthan had the foresight of understanding the importance of Computers and had started computer courses at rural place like Dighi way back in the year 1992. Courses for Tally, IT and DTP are being conducted regularly since then as per Government approved curriculum. Our Pratishthan is now a Franchisee of MITech for the CCIT course. There were 40 students for this course. Also we conducted basic computer fundamental course for women. 11 women participated in this course, out of which 5 students were from Snehdeep Jankalyan foundation. In addition to this, "Computer Fundamental" course was conducted for 15 students of the foundation / Snehdeep Jankalyan Foundation. Shobhana Paranjpe and Sandhya Palav were the trainers of these courses.

Certificates for completion of both the courses were distributed to the students by Dr. Bhooshan Kelkar (Country Manager UR – IBM India). On behalf of IBM Foundation, he donated a laptop to BNP and also conducted a session on “Online job applications” for the students of this course.

Vocational Training :

While considering the scope for professional training for women, our organization has started a special courses such as Computerized Machine Embroidery, Fashion designing/ Hand & Machine Embroidery. This year 25 women benefited from these training courses.

Tanuja Deshpande trained the women to make purses, handbags, cushion covers, bed covers, quilts etc. from the geometric shapes of a cloth. Smita Dharmadikari trained them to make Rangoli designs on water and krosha / crochet work on saree.

In order to motivate the women towards self learning and earning, BNP members visited Tata Motors Grihini Udyog / Women Project, on 26th November 2011.

Science and technology:

Last year, a novel science program was launched by the Pratishthan for children from 5th to 7th std where science experiments were conducted by our volunteers in their school. This year also we received overwhelming response for this activity. This program was conducted in four schools namely D.R. Nagarkar School, Saint Crispin’s Home, Ratnaprabha Mohite Patil school in Pune City and Ramchandra Gaikwad school at Dighi. Also this activity was conducted for 8th and 9th std students in Ratnaprabha Mohite Patil school.

A Robotics workshop was organized in different schools. This workshop was sponsored by Mahindra Life Space Pvt Ltd., Rotary club of University and Ratnaprabha Mohite Patil School. About 208 students benefited from this workshop. Workshop was also held at Vitthalrao Joshi charitable Trust, Deravan.(12 students had an advantage of this workshop);

On 25th February 2012, a science exhibition was organized at our science laboratory, on the occasion of science day. Professors, teachers, students and their parents visited this exhibition, where the participants explained and demonstrated these scientific experiments.

Self Study Centre (Abhyasika):

For the last 13 years a Self Study Centre is run successfully for girls and boys from 1st std to 7th std. Besides helping out with school curriculum, personal attention is also given to personality development of the students. We daily provide nutritious diet to these girls and boys.

Like every year, we had cultural programs for this boys and girls On 15th August 2011, 50 students participated in a drawing competition which was conducted under examination on Charuta Khamkar.

On 26th January 2012, prize distribution ceremony was held. Mr and Mrs Balkrishna Kulkarni (M/s Vastushodh construction company) were the guest of honor for the same.

Hobby workshops were conducted during school vacations. The girls and boys from Ratnaprabha Mohite Patil school, Manavya Sanshta and Dighi Abhyasika enjoyed these workshops.

Trip for Self Study Centre students was organized as Agakhan Palace. Shubhada Joshi and her assistants exhibited some collection of cuttings about Bal Mitra, Writers, Jokes, stories etc. from Newspapers like Sakal, Maharashtra Times, Loksatta, Pudhari etc.

Cultural Programmes :

'Rasamayi Vachan Mandal' organized a lecture on 6th April 2011 by famous writer Shobha Bondre to share her interesting experiences that she encountered while interviewing different celebrities.

Also on occasion of International chemistry year, a lecture by Dr. Sushama Jog (Prof in Modern college), on "Chemistry – a science in day to day life" was arranged by 'Rasamayi Vachan Mandal' and 'Science center on BNP'

On 22nd October 2011, a musical concert on Hindi – Marathi songs was arranged for members and employees of BNP, girls and boys of Abhyasika and local people from Dighi. This program was sponsored by HDFC Bank.

Interaction:

We are receiving responses from various educational, social and corporate organizations for our innovative activities.

We are regularly receiving funds, donations from Friends of Germany (Bremen), Rotary Club of Poona West, Persistent, UshaTai Sathe Marriage Bureau, Arunkumar Pandit and Give India, Give US to execute our activities. HDFC Bank Ltd donated funds for Speech Therapy and Correction center and other activities.

Bhagini Nivedita Pratishtan Pune is very grateful to all of them.

The main objective of our organization is to help needy, poor and underserved women and girls from society and make them capable and independent and also help them face life with self respect, determination and courage. Our true success lies in the implementation of multi-purpose programs in broad cross-section of society.

We have been blessed by active support of all our well wishers, donors, volunteers and Dignitaries from all sections of the society to make us successful in taking us closer to achieving our goals. We will always remain indebted to all of them.

We need to upgrade the amenities and facilities at our various centers to effectively serve and meet our goals. There is a need to renovate the Self Study Center and Computer training center. Also, the need for more facilities for development and health of children is very pressing. We have also chalked out new training schemes for creating employment opportunities for women. Indeed, lot of funds will be required for all these activities.

NOTES ON BALANCE SHEET AS AT 31.03.2012 AND INCOME AND EXPENDITURE ACCOUNT FOR THE YEAR ENDED ON 31.03.2012

1. SIGNIFICANT ACCOUNTING POLICIES.

Fixed Assets and Depreciation

Fixed assets are state as cost less accumulated depreciation. Depreciation on fixed Assets is provided on Written Down Method, at rates specified under Income Tax Rules.

Income

It is policy of the Trust to take into account income by way of grants, donation, interest and other receipts as and when it is actually received.

Investment

Investments are stated at cost.
